## **Email from Novitas and First Coast**

We'd like to express our sincere appreciation to the American Academy of Physical Medicine and Rehabilitation (AAPM&R) and everyone who joined today's discussion with First Coast Service Options Lead Executive Contractor Medical Director Dr. Anitra Graves, Novitas Solutions CMD Dr. Peter Goldzweig, and Novitas Solutions CMD Dr. Eric Kerstman. Your time and engagement in addressing the ICD-10 diagnosis issue related to the Billing and Coding Article: *Botulinum Toxins* (A58423) were invaluable.

Together, we explored options for a temporary solution until new diagnosis codes specific to spasticity secondary to related types of paralysis can be developed. We've prioritized implementing this temporary solution in both the Novitas and First Coast Billing and Coding Article and our systems. Once we have a clearer timeline, we'll share an estimated resolution date and confirm when the update is fully in place.

Please note, the planned update—using diagnosis code **M62.838** along with the specified codes highlighted in the attachment provided by Ms. Carolyn Millett on November 19, 2025—should not impact patient care. This administrative solution is being developed to implement *existing* LCD coverage for this service; therefore, providers should continue performing these services and may either hold claims until the fix is implemented or submit them for <u>reopening</u> if denied prior to the system update.
